Bye-laws: ARTICLE 12 - INDEXATION OF SUBSCRIPTIONS:

"Subscriptions will be increased yearly by the inflation rate in Belgium, unless otherwise proposed by the Executive Committee and decided by the General Assembly. The figures will be rounded up to the next multiple of ten Euros".
